**Q8. Is there a different methodology you would like to see in addition to in-person community conversations to collect this data?**

In addition to in-person community conversations, the Stakeholder Engagement Framework indicates that community surveys sent out via a variety of methods would be used, and the City encourages the state to use that method. The survey questions should be developed with an eye toward surveys that have already been used in the State and with validated questions that can be compared in PA and nationally. Consider the Philadelphia Internet Household Survey and the Digital Access and Skills survey put out by Seattle Washington. Any survey should also consider using best practices on community engagement and in consultation with practitioners and lived experts in communities to ensure that the conversations are effective and meaningful. Trusted community organizations should be engaged and empowered to encourage community members to complete the survey and provide assistance where digital skills, literacy, or language access may be a barrier. The PABDA should also consider ongoing feedback loops, for example, hosting a survey on the website and a hotline as North Carolina does, where folks can call in, take a survey, or record their needs/stories on their own time. Enabling anyone in the Commonwealth to easily sign up to a listserv or newsletter can also be a transparent and simple way to offer ongoing opportunities for engagement with communities.

It would be especially helpful to understand how these barriers differ by county, and whether issues such as affordability and availability are greater challenges in certain regions of the Commonwealth compared to others.
