I. Call to Order

Chairman Eachus called the meeting to order, and Mary Markle provided housekeeping, conducted roll call, and confirmed quorum.

II. Approval of September 12, 2024, Minutes

Chair Eachus asked for a motion to approve the September 12, 2024, meeting minutes as presented to the committee. Bill Wiedenheft motioned, and Steve Samara seconded. Minutes are approved.

III. Authority Updates

a. CPF

Greg Alliger provided an update noting that all but three sub-awardees are under contract. He stated that permitting and make ready have begun and the PBDA is working with the Office of Transformation & Opportunity on permitting issues and the Public Utility Commission on pole attachment issues, as they arise. First construction is expected to begin by the end of Q1.

Chair Eachus will offer an update on prevailing age later in the meeting. Mr. Alliger mentioned that on the PBDA website is a Prev Wage FAQ from L&I.

b. Broadband Ready Communities (BBRC)

Mr. Alliger reminded the committee that BBRC allows an opportunity for municipalities to demonstrate readiness for project deployment. He stated that the program was revamped due to an initial low response. The application was streamlined and simplified with a significant reduction in the number of questions. Mr. Alliger noted that there has been uptick in responses.

c. BEAD

Chuck Napier presented a BEAD update, in which he offered a map of eligible project locations, as well as the BEAD timeline noting dates that included application period one, application review period, application period two, final proposal and notice of award.

Chair Eachus asked for a motion to approve the 2025 dates. Bill Wiedenheft made a motion which was seconded by Dj Ryan. Motion passed.

V. Subcommittee Members Updates

Jim Gardler asked if someone could speak to concerns with the upcoming change in the administration.

Chuck Napier stated that the program was designed to go through multiple administrations and the PBDA is moving forward.

Chair Eachus mentioned several items, including the imminent changes to administrators at the federal level and the speculation that a pause to BEAD may be coming as well as changes to the program related to affordability, wages, fiber, etc.

Mr. Eachus also shared that a grievance was filed by Verizon and hearings will be throughout February and expressed concern about funds being tied up. He went on to share that providers have shared with him, concerns that the outcome of the hearings will change rules and conditions in the second round.

He also mentioned that pole attachment issues remain at the forefront, citing a report that Met-Ed is going to assess a new fee related to pole attachment.

Lastly, he asked the committee to give thought to what happens to BSLs not served due to project failure.

Mr. Alliger asked that Mr. Eachus direct anyone with pole attachment issues to reach out to the PBDA infrastructure team.
